The Board of Directors of the Lower Township Municipal Utilities Authority (LTMUA) is pleased to announce funding approval for extension of water service to the East Villas section of Lower Township. The expansion of water service into East Villas will be completed in two phases. The \$3.7 million dollars in financing for Phase One will be provided by The United States Department of Agriculture Rural Development. This loan, which is payable over 40 years at 2.125%, will provide permanent financing for the project.

The Board passed a series of resolutions at the August 5, 2015 meeting that directs LTMUA Staff and Professionals to proceed with developing the plans and specifications for construction, to submit applications for approval from New Jersey Department of Environmental Protection, the New Jersey Department of Transportation and the Local Public Finance Board and obtain temporary financing for construction.

Once construction is complete homeowners will receive a notification that they have one year to connect to water system.

How much will this cost each customer?

The cost of connecting to the water system includes a connection fee due to LTMUA and the cost to have a plumber / contractor connect the piping in your house to the water meter. There are several options available to assist our new water customers in funding these expenses.

Options for Financing.

LTMUA Connection Fee payment plan.

The LTMUA has a 5 year no interest payment plan available for the connection fee. An initial \$320.00 payment is made followed by annual payments until the balance is paid off. There is no interest on this payment plan providing the annual \$320 payment when due.

New Jersey Housing and Mortgage Finance Agency

The New Jersey Housing and Mortgage Finance Agency (NJHMFA) offers a interest free 10 year loan financing program to assist owners of single-family residences with the costs associated with connecting to extension of the water system in East Villas. The NJHMFA will finance the connection fee and cost associated with connecting the home to the water system up to \$10,000. The loan is payable over 10 years with a 1% year carrying fee. The application fee is \$75.00 which includes processing and recording of a second mortgage lien on the property. Representatives from NJHMFA will be available at the LTMUA Administration Building to answer your questions and assist you in applying for the Loan.
